Niemann & Sons Music School Instrument Rental Terms & Conditions This is NOT a Rent-To-Own Contract

- Initial Payment: The first three of rent are due when the instrument is rented. This payment is non-refundable. Exception: two full month of rent are due when an instrument is rented for the School District's Summer Music Program.
- 2. **Rental Period:** After you initial payment period, rent is billed month-to-month, and falls due on or before the first business day of the month. You may pay in advance for subsequent months, but such payments are **non-refundable** in the event you return the instrument early.
- 3. **Payments:** You will receive a monthly statement from Niemann & Sons Music if you declined Auto Pay. Rent is due on the first of each month. Pleas pay on time! If you enrolled in the Auto Pay system then your bank account will be charged between the 1st and the 5th and no statement will be mailed to you.
- 4. Rental Returns: You may return the instrument at any time. Please be aware that Niemann & Sons Music DOES NOT pro-rate for a partial month at the end of your rental period. Any past due payments, service charges, late fees, or repair bills must be paid at the time of the instrument's return. If the instrument is returned within one week of the end of school in June, rent for June will not be assessed.
- 5. Default: The instrument remains the sole property of Niemann & Sons Music. If the renter defaults on any provisions of this agreement, Niemann & Sons Music has the right to take possession of the instrument without legal process. Renter agrees to pay all reasonable costs incurred by Niemann & Sons Music (including sheriff's services, attorney's fees, collection costs and court costs) in collecting amounts due. A \$25 minimum collection fee will be added on any account that becomes delinquent beyond 30 days if Niemann & Sons Music deems it necessary to collect at the renter's house, place of business, or at the school. This fee applies for each attempt made.
- 6. **Upkeep and Maintenance:** Niemann & Sons Music certifies that instrument is in proper playing condition when it is rented. You are responsible for the upkeep and maintenance of the instrument as well as any damage beyond normal wear, including accidental damage caused by you, your child, or your child's teacher.
- 7. Purchase Credit for Six Months Rent: Provided your account is in good standing, Niemann & Sons Music will credit up to six months of paid rent toward the purchase of a new or used instruments. This does not constitute a rent-to-own agreement. Any rent paid after six months WILL NOT be credited toward a future purchase.
- 8. Late Payments: Past due accounts shall be subject to late fees as follows: Accounts that become 30 days past due will incur a late fee of \$15. Accounts that become 60 days past due will be assigned to a collection agency for collection assistance. The amount due at that time will be the retail price of the instrument charged on your account, plus any rent and fees owed plus all collection/ attorney fees. This is an automatic turnover unless prior arrangements have been approved by Niemann & Sons Music. PLEASE NOTE: you will receive written correspondence from Niemann & Sons Music prior to your account being assigned to collections. Please do not hesitate to communicate if you need to make special payment arrangements.
